### Intervenor.

Become a full participant in the JRP process.



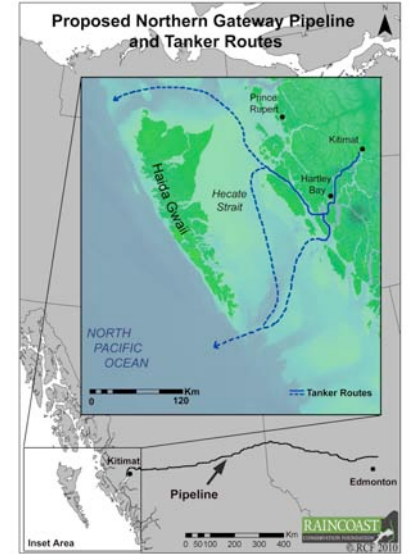
- Allows you to:
  - ✓ Receive all documentation submitted to the JRP
  - ✓ Submit written or oral evidence
  - ✓ Submit information requests
  - ✓ Participate in questioning periods and motions
  - ✓ Question Northern Gateway
  - ✓ Provide final argument
- Intervenors may be cross-examined
- You must indicate your reasons for concern; registration must include items from the **LIST OF ISSUES**
- **Register by July 14, 2011**

### THE JOINT REVIEW PANEL

(JRP) is an 'independent body' assessing the environmental effects of the **Proposed Enbridge Northern Gateway Project**. The review process is said to be **transparent and open to the public**.

### THE PANEL NEEDS TO HEAR FROM US!

Share your knowledge and voice your passion by making an Oral Statement.



### Oral Statements.

Allows you to present personal views, experiences and concerns at a community hearing.



- Researched and rehearsed, or just speak from the heart
- People's thoughts, concerns, and emotions are important for the panel to make the right decision
- Oral statements should be about 10 minutes
- You may be asked some questions to explain what you've said
- **Register by October 6, 2011**

### THE THREE MEMBERS OF THE JRP:

- Are not from BC
- **Don't have marine experience**
- Don't have a connection to Coastal First Nations
- Are paid by Enbridge
- Will determine **the fate of Haida Gwaii** and all of BC's coastal communities

### HAIDA GWAII NEEDS TO PARTICIPATE IN THE JRP!

The inexperienced panel can **only consider information presented within the joint review process**. To effectively voice your concerns and show the panel what is at risk, you must register.

### Letters of Comment.

Write a letter to the panel with your views and concerns.



- All written submissions will be considered—from letters of a Kindergarten class to a technical report
- Present fact or evoke feeling
- **The Panel must receive your comments by March 13, 2012**
